**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF
ONE (1) BRAND NEW UNIT OF MULTI-PURPOSE 8-SEATER VAN
FOR OFFICIAL USE BY THE PERSONNEL OF THE
CONSULATE GENERAL OF THE PHILIPPINES IN NAGOYA**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of **one (1) brand new unit of multi-purpose 8-seater van** for official use by its personnel;

WHEREAS, the procurement of said vehicle has an Approved Budget for the Contract to be sourced from Nagoya PCG's 2019 continuing appropriation in the amount of **TWO MILLION SIX HUNDRED FIFTY THOUSAND PESOS (PhP 2,650,000)** only or approximately **FIVE MILLION THREE HUNDRED JAPANESE YEN (JPY 5,300,000)**, is included in the Department's Annual Procurement Plan (APP) for CY 2019;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the temporary office of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 18 December 2020;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **AICHI NISSAN MOTORS (DID NOT SUBMIT A QUOTATION)**, the **HONDA CARS CHIYODA (DID NOT MEET TECHNICAL REQUIREMENTS)** and the **NAGOYA TOYOPET CO. LTD.** which submitted the lowest calculated and most responsive quotation in the amount of **FIVE MILLION JAPANESE YEN (JPY 5,000,000)**, excluding tax, or **TWO MILLION FIVE HUNDRED PESOS (PhP 2,500,000.00)**.

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of one (1) brand new unit of **TOYOTA ALPHARD X 2500 CC 8-SEATER MULTI-PURPOSE VAN** from the **NAGOYA TOYOPET CO., LTD**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
