RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF NINETEEN (19) PIECES OF DOWN JACKET FOR OFFICIAL USE BY THE PERSONNEL OF THE CONSULATE GENERAL OF THE PHILIPPINES, NAGOYA

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of nineteen (19) pieces of down jacket for official use by its personnel in observance of the 19-day Campaign to End Violence Against Women (VAW), a Gender and Development (GAD) activity;

WHEREAS, the procurement of nineteen (19) pieces of down jacket has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' GAD Funds in the amount of **FIFTY THOUSAND ONE HUNDRED TEN PESOS (Ph50,110.00)** or approximately **ONE HUNDRED FOURTEEN THOUSAND THREE HUNDRED JAPANESE YEN (JPY 114,300)**;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 12 November 2021;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations online from three (3) different suppliers, namely: the **MONT-BELL (QUOTATION INSUFFICIENT)**, the **AMAZON JAPAN (QUOTATION INSUFFICIENT)** and the **UNIQLO CO., LTD.** which provided the lowest calculated and most responsive quotation in the amount of **ONE HUNDRED TWENTY-EIGHT THOUSAND EIGHTY-NINE YEN (JPY128,089)** or approximately **FIFTY-SIX THOUSAND ONE HUNDRED FIFTY-FIVE PESOS AND 20/100 (PhP56,155.20)** only, including tax and other charges.

WHEREAS, the UNIQLO outlet in Nagoya agreed to include printing the VAW sign and logo of the Consulate in every jacket to the total cost of the contract;

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of nineteen (19) pieces of down jacket from the UNIQLO CO., LTD., subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
