**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF ONE (1) BRAND NEW SEDAN FOR USE AS OFFICIAL CAR OF THE HEAD OF POST OF THE CONSULATE GENERAL OF THE PHILIPPINES, NAGOYA**

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of **one (1) brand new sedan** for use as official car for the exercise of executive functions of the Head of Post of the Consulate General of the Philippines, Nagoya;


**WHEREAS**, the procurement of said vehicle has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2021, in the amount of **FOUR MILLION FOUR HUNDRED THOUSAND PESOS (PhP4,400,000.00)** only or approximately **NINE MILLION ONE HUNDRED THIRTY-ONE THOUSAND NINE HUNDRED NINE JAPANESE YEN (JPY9,131,909)**, is included in the Department's Annual Procurement Plan (APP) for CY 2021;

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the website of the Consulate General of the Philippines, Nagoya starting on 16 November 2021;

**WHEREAS**, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **LEXUS (QUOTATION SUBMITTED ABOVE ABC)**, the **YANASE BMW (QUOTATION SUBMITTED ABOVE ABC)** and the **MERCEDES-BENZ JAPAN CO., LTD.** which submitted the lowest calculated and most responsive quotation in the amount of **EIGHT MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND TWENTY-FIVE JAPANESE YEN (JPY 8,577,025)**, excluding tax, or **FOUR MILLION ONE HUNDRED THIRTY-TWO THOUSAND SIX HUNDRED FORTY-ONE PESOS AND 56/100 (PhP 4,132,641.56)**.

**NOW, THEREFORE**, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of one (1) brand new unit of **MERCEDES-BENZ E 450 4MATIC EXCLUSIVE (RHD)**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.


