**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF
ONE (1) UNIT OF DOT IMPACT PRINTER**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of one (1) unit of Dot Impact Printer for use in its offices at Hiroya building;

WHEREAS, the procurement of one (1) unit of dot impact printer has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2020 Continuing Appropriations in the amount of **TWENTY-SEVEN THOUSAND FIVE HUNDRED NINETEEN PESOS AND 40/100 (PhP27,519.40)** or approximately **FIFTY-FIVE THOUSAND THIRTY-EIGHT YEN (JPY55,038)**;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 2 December 2021;

WHEREAS, the dot impact printer is not available at leading electronics and appliance shops in Nagoya;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations online from three (3) different suppliers, namely: the **RAKUTEN JAPAN (QUOTATION ABOVE ABC)**, the **EPSON JAPAN (QUOTATION ABOVE ABC)** and the **AMAZON JAPAN** which provided the lowest calculated and most responsive quotation in the amount of **FORTY-SIX THOUSAND SEVEN HUNDRED NINETY-FOUR YEN (JPY46,794)** or approximately **TWENTY-THREE THOUSAND THREE HUNDRED NINETY-SEVEN PESOS (PhP23,397.00)** only, excluding shipping charges and tax.

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of one (1) unit of EPSON VP-D500 Dot Impact Printer from the **AMAZON JAPAN**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
