RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR THE PROVISION OF A ONE-DAY FLOOR CLEANING SERVICES

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of a contract for the provision of a one-day floor cleaning services for its four-storey office space at Hiroya building in 2021;

WHEREAS, the procurement of a contract for the provision of a one-day floor cleaning services has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2021 in the amount of SEVENY-FIVE THOUSAND PESOS (PhP75,000.00) or approximately ONE HUNDRED FIFTY THOUSAND YEN (JPY150,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the ~~(temporary office of the)~~ Consulate General of the Philippines, Nagoya reserved for this purpose starting on 1 April 2021;


WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **ASAHI FACILITIES CO. LTD. (QUOTATION SUBMITTED ABOVE ABC)**, the **TSUSHIMA BISO CO. LTD. (QUOTATION SUBMITTED ABOVE ABC)** and the **EIKO CO. LTD.** which showed the lowest calculated and most responsive quotation, in the amount of **ONE HUNDRED FORTY-SEVEN THOUSAND ONE HUNDRED EIGHTY JAPANESE YEN (JPY147,180)** or approximately **SEVENTY-THREE THOUSAND FIVE HUNDRED NINETY PESOS (Php73,590.00)** only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for the provision of a one-day floor cleaning services for the Consulate General's four-storey office space at Hiroya building, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
