RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF VARIOUS PIECES OF OFFICE FURNITURE

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of various pieces of furniture for use in its offices at Hiroya building;

WHEREAS, the procurement of various pieces of office furniture has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2020 Continuing Appropriations in the amount of ONE MILLION SIX HUNDRED SIXTY-NINE THOUSAND FIVE HUNDRED TWENTY-FIVE PESOS AND 92/100 (PhP1,669,525.92) or approximately THREE MILLION THREE HUNDRED THIRTY-NINE THOUSAND FIFTY-ONE JAPANESE YEN (JPY3,339,051);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website of the Consulate General of the Philippines, Nagoya starting on 12 November 2021;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations from three (3) different suppliers, namely: the KARIMOKU (INSUFFICIENT QUOTATION SUBMITTED), the CASSINA (INSUFFICIENT QUOTATION SUBMITTED) and the OTSUKA KAGU, LTD. which submitted the most sufficient, lowest calculated, and most responsive quotation in the amount of ONE MILLION NINE HUNDRED FOUR THOUSAND SEVENTY-SEVEN JAPANESE YEN (JPY1,904,077) or approximately NINE HUNDRED FIFTY-TWO THOUSAND THIRTY EIGHT PESOS AND 50/100 (Php952,038.50) only, excluding tax and including delivery fee.

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of various pieces of office furniture from the OTSUKA KAGU, LTD., subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
