RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF THREE (3) UNITS OF AIR PURIFIER WITH HUMIDIFIER

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of three (3) units of air purifier with humidifier for use in its offices at Hiroya building;

WHEREAS, the procurement of three (3) units of air purifier has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2020 Continuing Appropriations in the amount of **ONE HUNDRED THIRTY-NINE THOUSAND THREE HUNDRED SEVENTY-TWO PESOS AND 44/100 (PhP139,372.44)** or approximately **TWO HUNDRED EIGHTY-NINE THOUSAND TWO HUNDRED FIFTY-EIGHT YEN (JPY289,258)**;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 12 November 2021;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations from three (3) different suppliers, namely: the **BIC CAMERA (QUOTATION SUBMITTED ABOVE ABC)**, the **YODOBASHI CAMERA (QUOTATION SUBMITTED ABOVE ABC)** and the **OTSUKA KAGU, LTD.** which submitted the lowest calculated and most responsive quotation in the amount of **TWO HUNDRED THIRTY-TWO THOUSAND SIX HUNDRED TWENTY JAPANESE YEN (PhP232,620)** or approximately **ONE HUNDRED TWELVE THOUSAND EIGHTY-TWO PESOS AND 57/100 (PhP112,082.57)** only, excluding tax.

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of three (3) units of air purifier with humidifier from the **OTSUKA KAGU, LTD.**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
