**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT  
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF  
THREE (3) UNITS OF DESKTOP COMPUTER**

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of three (3) units of desktop computer for use in its offices at Hiroya building;

**WHEREAS**, the procurement of three (3) units of desktop computer has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2020 Continuing Appropriations in the amount of **THREE HUNDRED SEVENTY-ONE THOUSAND NINE HUNDRED ONE PESOS AND 36/100 (PhP 371,901.36)** or approximately **SEVEN HUNDRED FORTY-THREE THOUSAND EIGHT HUNDRED TWO PESOS AND 72/100 (PhP 743,802.72)**;

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 23 November 2021;

**WHEREAS**, the Consulate General of the Philippines, Nagoya obtained quotations from three (3) different suppliers, namely: the **YODOBASHI CAMERA (DID NOT MEET TECHNICAL REQUIREMENTS)**, the **BIC CAMERA (DID NOT MEET TECHNICAL REQUIREMENTS)** and the **DELL TECHNOLOGIES JAPAN, INC.**, which submitted the lowest and most responsive quotation in the amount of **SEVEN HUNDRED THREE THOUSAND EIGHT HUNDRED JAPANESE YEN (JPY703,800)** or approximately **THREE HUNDRED FIFTY-ONE THOUSAND NINE HUNDRED PESOS (PhP351,900.00)** only, excluding tax.

**NOW, THEREFORE**, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of three (3) units of desktop computer from the **DELL TECHNOLOGIES JAPAN**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
