RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF TWELVE (12) UNITS OF FOLDABLE FLOOR DIVIDER

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of twelve (12) units of Foldable Floor Divider for use in its offices at Hiroya building;

WHEREAS, the procurement of twelve (12) units of foldable floor divider has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2020 Continuing Appropriations in the amount of TWO HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED SIX PESOS AND 06/100 (PhP 218,706.06) or approximately FOUR HUNDRED THIRTY-SEVEN THOUSAND FOUR HUNDRED TWELVE JAPANESE YEN (JPY 437,412);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 2 December 2021;

WHEREAS, the foldable floor divider is not available at leading furniture shops in Nagoya;


WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations online from three (3) different suppliers, namely: the **ASKUL (QUOTATION ABOVE ABC)**, the **AMAZON JAPAN (QUOTATION ABOVE ABC)** and the **OFFICE-COM CO. LTD.** which provided the lowest calculated and most responsive quotation in the amount of THREE HUNDRED NINETY-FIVE THOUSAND EIGHT HUNDRED EIGHTY JAPANESE YEN (JPY 395,880) or approximately ONE HUNDRED NINETY-SEVEN THOUSAND NINE HUNDRED FORTY PESOS (PhP197,940.00) only, including tax and other charges,

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of twelve (12) units of foldable floor divider from the **OFFICE-COM JAPAN**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
