RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF ONE UNIT OF STORAGE CABINET (2-DOOR)

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of one unit of storage cabinet (2-door) for use in its offices at Hiroya building;

WHEREAS, the procurement of a storage cabinet has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2021 Continuing Appropriations in the amount of **FIFTY-EIGHT THOUSAND FOUR HUNDRED FORTY-NINE PESOS AND 35/100 (Php58,449.35)** or approximately **ONE HUNDRED FIFTY-ONE THOUSAND SIX HUNDRED EIGHTY-SIX JAPANESE YEN (JPY151,686.30)**;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 18 July 2022;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations from three (3) different suppliers, namely: the **MUKU STORE (QUOTATION ABOVE ABC)**, the **RAKUTEN (QUOTATION ABOVE ABC)** and the **YAMADA DENKI CO. LTD. (formerly IDC OTSUKA)** which submitted the lowest calculated and most responsive quotation in the amount of **ONE HUNDRED FORTY-TWO THOUSAND FOUR HUNDRED JAPANESE YEN (JPY142,400)** or approximately **FIFTY-FOUR THOUSAND EIGHT HUNDRED SEVENTY-ONE PESOS AND 06/100 (Php54,871.06)** only, excluding tax and including delivery fee.

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of one unit of storage cabinet from the **OTSUKA KAGU, LTD.**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
