RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF COMPULSORY AND VOLUNTARY CAR INSURANCE POLICY

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a compulsory and voluntary car insurance policy coverage for its newly acquired official car (Mercedes Benz E450 4MATIC Exclusive);

WHEREAS, the procurement of car insurance policy has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2022, in the amount of PhP248,000.00 or approximately JPY565,000, is included in the Department's Annual Procurement Plan (APP) for CY 2022;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 10 February 2022;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different providers namely: the SOMPO JAPAN (SUBMITTED A QUOTATION BUT DID NOT MEET TECHNICAL REQUIREMENTS) the TOKYO MARINE (SUBMITTED A QUOTATION BUT DID NOT MEET TECHNICAL REQUIREMENTS) and the MITSUI SUMITOMO INSURANCE CO., LTD., which submitted the lowest calculated and most responsive quotation in the amount of FOUR HUNDRED EIGHTY-THREE THOUSAND THREE HUNDRED FOURTY YEN (JPY483,340) or TWO HUNDRED TWELVE THOUSAND THIRTY-NINE PESOS AND 15/100 (Php212,039.15) only, exclusive of tax.

NOW, **THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of compulsory and voluntary car insurance policy coverage for its official car, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
