**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT
OF A FILING CABINET SYSTEM**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of a filing cabinet system for use in its offices at Hiroya building;

WHEREAS, the procurement of a filing cabinet system has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs' Building Fund FY 2021 Continuing Appropriations in the amount of **SIX HUNDRED SIXTY-EIGHT THOUSAND THREE HUNDRED THIRTY-NINE PESOS AND 42/100 (PhP668,339.42)** or approximately **ONE MILLION SIX HUNDRED SIXTY-FOUR THOUSAND SIX HUNDRED SIX (JPY1,664,606)**;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 13 October 2022;

WHEREAS, the Consulate General of the Philippines, Nagoya obtained quotations from three (3) different suppliers, namely: the **TAIYO LTD. CO. (QUOTATION SUBMITTED INSUFFICIENT)**, the **JI TECH CO. LTD. (QUOTATION SUBMITTED INSUFFICIENT)** and the **SHINODA SHOKAI CO. LTD.** which submitted the lowest calculated and most responsive quotation in the amount of **ONE MILLION FIVE HUNDRED TEN THOUSAND SIX HUNDRED JAPANESE YEN (JPY1,510,600)** or approximately **FIVE HUNDRED NINETY-THREE THOUSAND SIX HUNDRED SIXTY-FIVE PESOS AND 80/100 (PhP593,665.80)** only, excluding tax;

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of one (1) filing cabinet system from the **SHINODA SHOKAI CO. LTD.**, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




