RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR THE LEASE OF VENUE WITH CATERING FOR THE RECEPTION TO COMMEMORATE THE 124TH ANNIVERSARY OF THE PROCLAMATION OF PHILIPPINE INDEPENDENCE ON 13 JUNE 2022

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a contract for the lease of venue with catering for the reception it will host to commemorate the 124th Anniversary of the Proclamation of Philippine Independence on 13 June 2022:

WHEREAS, the procurement of a contract for the lease of venue with catering for the said activity has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2022 in the amount of FIVE HUNDRED FORTY-NINE THOUSAND PESOS (PhP549,000.00) or approximately ONE MILLION ONE HUNDRED THOUSAND YEN (JPY1,100,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 12 May 20221;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **KANKO HOTEL NAGOYA (QUOTATION SUBMITTED ABOVE ABC)**, the **TOKYU HOTEL NAGOYA (QUOTATION SUBMITTED WAS INSUFFICIENT)** and the **HILTON NAGOYA** which submitted the most responsive quotation, in the amount of **NINE HUNDRED NINETY-EIGHT THOUSAND THREE HUNDRED SIXTEEN JAPANESE YEN (JPY998,316)** or approximately **FOUR HUNDRED EIGHTY-NINE THOUSAND NINE HUNDRED THIRTY-FIVE PESOS (PhP489,935.00)** only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for the lease of venue with catering for the reception to commemorate the 124th Anniversary of the Proclamation of Philippine Independence on 13 June 2022, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
