RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR THE LEASE OF VENUE WITH MEALS FOR NAGOYA PCG'S TEAM BUILDING ACTIVITY AND OCULAR VISIT TO FUKUI AND ISHIKAWA, 22-23 OCTOBER 2022

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a contract for the lease of venue with meals for the conduct of Post's Team Building Activity and Ocular Visit to Fukui and Ishikawa Prefectures on 22-23 October 2022;

WHEREAS, the procurement of a contract for the lease of venue with meals for the said activity has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2022 in the amount of ONE HUNDRED FIFTY THOUSAND PESOS (PhP150,000) or approximately THREE HUNDRED THOUSAND YEN (JPY300,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 2 September 2022;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the HOTEL ROUTE INN FUKUI (QUOTATION SUBMITTED WAS INSUFFICIENT), the AZ INN FUKUI (QUOTATION SUBMITTED WAS INSUFFICIENT) and the HOTEL FUJITA FUKUI which submitted the most responsive quotation, in the amount of TWO HUNDRED SEVENTY-ONE THOUSAND SEVEN HUNDRED JAPANESE YEN (JPY271,700) or approximately ONE HUNDRED TEN THOUSAND PESOS (Php110,000.00) only, inclusive of taxes and other charges

**NOW**, **THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for the lease of venue with meals for the conduct of Post's Team Building Activity and Ocular Visit to Fukui and Ishikawa on 22-23 October 2022, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
