RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR A ONE-DAY FLOOR CLEANING SERVICES

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake immediate procurement of a contract for a one-day floor cleaning services at its four-storey office space in Hiroya building, Sakae, Naka District, Nagoya;

WHEREAS, the procurement of a contract for the provision of a one-day floor cleaning services has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2022 in the amount of SEVENTY-FIVE THOUSAND PESOS (PhP75,000.00) or approximately ONE HUNDRED EIGHTY-ONE THOUSAND EIGHT HUNDRED SIXTY-TWO YEN (JPY181,862).

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 21 November 2022;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **EIKO CO. LTD. (QUOTATION SUBMITTED INSUFICIENT)**, the **ADVANCE SERVICE CO. LTD. (QUOTATION SUBMITTED ABOVE ABC)** and the **ASAHI FACILITIES CO. LTD.** which showed the lowest calculated and most responsive quotation, in the amount of **ONE HUNDRED FORTY-THREE THOUSAND YEN (JPY143,000) or approximately FIFTY-EIGHT THOUSAND SIX HUNDRED ONE PESOS AND 40/100 (PhP58,601.40)** only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE to RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for a one-day floor cleaning services at the Philippine Consulate General's four-storey office space in Hiroya building, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
