RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR A ONE-DAY FLOOR CLEANING SERVICES

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement for a One-Day Floor Cleaning Services at its Four-Storey Office Space in Hiroya building, Sakae, Naka District, Nagoya;

WHEREAS, the procurement of a of a one-day floor cleaning services at its four-storey office space in Hiroya building has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Sixty-Seven Thousand Five Hundred Twenty Pesos (PhP67,520.00) or approximately One Hundred Sixty Thousand Yen (JPY160,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 08 May 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the ASAHI FACILITIES CO. LTD. (did not submit a quotation), the TSUSHIMA BISO CO. LTD. (did not submit a quotation) and the EIKO CO. LTD. which showed the lowest calculated and most responsive quotation, in the amount of One Hundred Fifty-Three Thousand Eight Hundred Eighty Yen (JPY153,880) or approximately Sixty-Four Thousand Nine Hundred Thirty-Seven and 36/100 Pesos (PhP64,937.36.00) only, inclusive of taxes and other charges

NOW, **THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for a one-day floor cleaning services at the Philippine Consulate General's four-storey office space in Hiroya building, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
