**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF SERVICES FOR A ONE-DAY FLOOR CLEANING SERVICES AT ITS FOUR-STOREY OFFICE SPACE IN HIROYA BUILDING, SAKAE, NAKA DISTRICT, NAGOYA**

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake procurement services for a One-Day Floor Cleaning Services at its Four-Storey Office Space in Hiroya building, Sakae, Naka District, Nagoya;

**WHEREAS**, the procurement of a contract for the procurement of services for a One-Day Floor Cleaning Services at its Four-Storey Office Space in Hiroya building, Sakae, Naka District, Nagoya has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Sixty-Seven Thousand Five Hundred Twenty Pesos (PHP67,520) only or approximately One Hundred Sixty Thousand Yen (JPY160,000) only.

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 10 October 2023;

**WHEREAS**, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **Advance Services Co. LTD.** (JPY257,400 – Exceeded ABC), the **Eiko Co. Ltd.** (JPY153,880 – Tax Exclusive) and the **Asahi Facilities Co. LTD. Nagoya Branch** which showed the lowest calculated and most responsive quotation, in the amount of **Fifty-Two Thousand Two Hundred Sixty-Seven Pesos (PHP52,267.00) only or approximately One Hundred Thirty Seven Thousand Five Hundred Yen (JPY137,500) only**, inclusive of taxes and other charges

**NOW, THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of services for a One-Day Floor Cleaning Services at its Four-Storey Office Space in Hiroya building, Sakae, Naka District, Nagoya, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
