RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A CONTRACT FOR THE LEASE OF VENUE WITH CATERING FOR THE RECEPTION TO COMMEMORATE THE 125TH ANNIVERSARY OF THE PROCLAMATION OF PHILIPPINE INDEPENDENCE ON 15 JUNE 2023

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a contract for the lease of venue with catering for the reception it will host to commemorate the 125th Anniversary of the Proclamation of Philippine Independence on 15 June 2023:

WHEREAS, the procurement of a contract for the lease of venue with catering for the said activity has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Two Hundred Thirty-Two Thousand One Hundred Pesos (PHP232,100.00) Or Approximately Five Hundred Fifty Thousand Yen (JPY550,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 27 April 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to four (4) different companies, namely: the **Nagoya Tokyu Hotel (quotation submitted above ABC)**, the **TKP Corporation (quotation submitted above ABC)**, the **Gatehouse (quotation submitted above ABC)** and the **Espacio Enterprise (Noritake no mori Restaurant Kiln)** which submitted the most responsive quotation, in the amount of **Five Hundred Fourteen Thousand Japanese Yen (JPY514,00) or approximately Two Hundred Sixteen Thousand Nine Hundred Eight Pesos (PHP216,908.00)** only, inclusive of taxes and other charges.

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for the lease of venue with catering for the reception to commemorate the 125th Anniversary of the Proclamation of Philippine Independence on 15 June 2023, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
