RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A COMPULSORY INSURANCE POLICY AND VOLUNTARY INSURANCE POLICY FOR THE OFFICIAL CAR OF THE PHILIPPINE CONSULATE GENERAL, NAGOYA

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a compulsory insurance policy and voluntary insurance policy coverage for its official car (Mercedes Benz E450 4MATIC Exclusive, 2021);

WHEREAS, the procurement of a compulsory car insurance policy and voluntary car insurance policy has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023, in the amount of ONE HUNDRED SEVENTY-SIX THOUSAND ONE HUNDRED NINETY-EIGHT PESOS AND 40/100 (PhP176,198.40) or approximately FOUR HUNDRED FOURTEEN THOUSAND YEN (JPY414,000), is included in the Department's Annual Procurement Plan (APP) for CY 2023;

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises and website of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 4 January 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different providers namely: the SOMPO JAPAN (SUBMITTED A QUOTATION BUT TECHNICAL SPECIFICATIONS INADEQUATE) the TOKYO MARINE (SUBMITTED A QUOTATION BUT TECHNICAL SPECIFICATIONS INADEQUATE) and the MITSUI SUMITOMO INSURANCE CO., LTD., which submitted the most responsive quotation in the amount of THREE HUNDRED SIXTY-FOUR THOUSAND ONE HUNDRED NINETY YEN (JPY364,190) or approximately ONE HUNDRED FIFTY-TWO THOUSAND SEVEN HUNDRED FORTY-ONE PESOS AND 28/100 (PhP152,741.28) only, exclusive of tax.

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of a compulsory insurance policy and voluntary insurance policy coverage for its official car, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
