RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF A COMPULSORY INSURANCE POLICY AND VOLUNTARY INSURANCE POLICY FOR THE SERVICE VEHICLE OF THE PHILIPPINE CONSULATE GENERAL, NAGOYA

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a compulsory insurance policy and voluntary insurance policy coverage for its service vehicle (Toyota Alphard HV X 2021);

WHEREAS, the procurement of a compulsory car insurance policy and voluntary car insurance policy has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023, in the amount of EIGHTY-NINE THOUSAND EIGHT HUNDRED SEVEN PESOS AND 34/100 (PhP89,807.34) or approximately TWO HUNDRED TWELVE THOUSAND SIX HUNDRED SIXTY-TWO YEN (JPY212,662), is included in the Department's Annual Procurement Plan (APP) for CY 2023:

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted in the premises and website of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 5 January 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different providers namely: the MITSUI SUMITOMO INSURANCE CO., LTD (SUBMITTED A QUOTATION BUT TECHNICAL SPECIFICATIONS INSUFFICIENT) the SOMPO JAPAN (SUBMITTED A QUOTATION BUT TECHNICAL SPECIFICATIONS INSUFFICIENT) and the TOKYO MARINE, which submitted the lowest and most responsive quotation in the amount of ONE HUNDRED EIGHT-FIVE THOUSAND SEVEN HUNDRED SEVENTY YEN (JPY 185,770) or approximately SEVENTY-FIVE THOUSAND FOUR HUNDRED FOUR PESOS AND 04/100 (Php75,404.04) only, exclusive of tax.

NOW, **THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the purchase of a compulsory insurance policy and voluntary insurance policy coverage for its service vehicle, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
