RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF MOBILE SUBSCRIPTION FOR THE CONSUL GENERAL

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of a Mobile Subscription for the Consul General;

WHEREAS, the procurement of a contract for the procurement of a Mobile Subscription for the Consul General n has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Two Hundred Forty-Thousand Yen (JPY240,000) approximately Ninety Thousand Five Hundred Pesos (PHP90,500.00) or Twenty Thousand Yen (JPY20,000) per month approximately Seven Thousand Six Hundred Pesos (PHP7,600.00) per month..

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 23 November 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **NTT Docomo** (JPY18,649/month or JPY223,788 – Failed due no available Insurance for the Phone Unit), the **Softbank Nagoya** (JPY13,330/month or JPY159,960 – Failed due no available Insurance for the Phone Unit) and the **AU Style Nagoya** which showed the lowest calculated and most responsive quotation, in the amount of **Fifteen Thousand One Hundred Fifty-Four Yen (JPY15,154) per month** approx. Five Thousand Seven Hundred Pesos (PHP5,700) per month or **One Hundred Eighty-One Thousand Eight Hundred Forty-Eight Yen (JPY181,848)** or approx. Sixty-Eight Thousand Three Hundred Fifty Pesos (PHP68,350) only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a Mobile Subscription for the Consul General, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
