RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF VARIOUS INFORMATION TECHNOLOGY EQUIPMENT AND OTHER REGULAR SUPPLIES AND OTHER SUPPLIES.

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of Various Information and Communications Technology Equipment and other Regular Supplies

WHEREAS, the procurement of a contract for the procurement of Various Information and Communications Technology Equipment and other Regular Supplies has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Four Hundred Eighty Thousand Yen (JPY480,000) or approximately One Hundred Eighty-Five Thousand Pesos (PHP185,000.00).

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 10 November 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **EDION** (*JPY72,600-Failed: Incomplete Items*), the **YAMADA DENKI CO. LTD.** (*JPY406,994-Failed: some items incompatible*) and the **BIC CAMERA, INC.** which showed the lowest calculated and most responsive quotation, in the amount of **Four Hundred Seventy Six Thousand Fourteen Yen (JPY476,014) only or approximately One Hundred Eighty-Four Thousand Pesos (PHP184,000.00) only**, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Various Information and Communications Technology Equipment and other Regular Supplies, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
