**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF VARIOUS SUPPLIES AND EQUIPMENT FOR THE CONSULATE'S DAILY OPERATIONS**

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake procurement of Various Supplies and Equipment for the Consulate's Daily Operations;

**WHEREAS**, the procurement of a contract for the procurement of Various Supplies and Equipment for the Consulate's Daily Operations has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of One Million Two Hundred Thousand Yen (JPY1,200,000) or approximately Four Hundred Forty-Five Thousand Pesos (PhP445,000.00).

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 06 November 2023;

**WHEREAS**, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **KAUNET** (*JPY2,309,525-Failed/Exceeded ABC*), the **MONOTARO Co. LTD** (*JPY2,489,078-Failed/Exceeded ABC*) and the **ASKUL** which showed the lowest calculated and most responsive quotation, in the amount of **One Million Ninety Thousand Nine Hundred Nine Yen (JPY1,090,909) only or approximately Four Hundred Four Thousand Two Hundred Pesos (PHP404,200.00) only**, inclusive of taxes and other charges

**NOW, THEREFORE**, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Various Supplies and Equipment for the Consulate's Daily Operations, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.




