## RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF REFRESHMENTS AND DRINKS FOR THE CONSULATE'S YEAREND EVALUATION AND CONSULTATION

**WHEREAS**, the Consulate General of the Philippines, Nagoya intends to undertake procurement for the Refreshments and Drinks for the Consulate's Yearend Evaluation and Consultation:

WHEREAS, the procurement of a contract for the procurement of Refreshments and Drinks for the Consulate's Yearend Evaluation and Consultation has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2023 in the amount of Three Hundred Thousand Yen (JPY300,000) only or approximately One Hundred Eleven Thousand Pesos (PhP111,000.00) only.

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 23 October;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the Kawabun Nagoya (JPY297,660-Pass), the Ristrante Antichi (JPY426,195-Failed/Exceeded ABC) and the Shooters Sports Bar & Grill which showed the lowest calculated and most responsive quotation, in the amount of Two Hundred Thirty-Five Thousand Yen (JPY235,000) only or approximately Eighty-Seven Thousand Pesos (PhP87,000.00) only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Refreshments and Drinks for the Consulate's Yearend Evaluation and Consultation, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
