**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE SHIPMENT OF
PERSONAL EFFECTS OF CONSUL GENERAL CELESTE VINZON-BALATBAT
FROM NAGOYA, JAPAN TO SANTIAGO, CHILE**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement for the Shipment of Personal Effects of Consul General Celeste Vinzon-Balatbat from Nagoya, Japan to Santiago, Chile;

WHEREAS, the procurement of Shipment of Personal Effects of Consul General Celeste Vinzon-Balatbat from Nagoya, Japan to Santiago, Chile has an Approved Budget for the Contract to be sourced from the Department of Foreign Affairs – Human Resource Management Office MOOE CY 2023 in the amount of Six Hundred Twenty-Five Thousand Eight Hundred Sixty Pesos (PHP625,860.00) or approximately One Million Five Hundred Thousand Yen (JPY1,500,000);

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 06 February 2023;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **Crown Moving Service Co. Ltd. (JPY1,453,960)**, the **Yamato Transport Co. (JPY2,100,000)** and the **Asian Tigers Japan** which showed the lowest calculated and most responsive quotation, in the amount of **One Million Four Hundred Fifty Thousand (JPY1,450,000) or approximately Six Hundred Four Thousand Nine Hundred Ninety-Eight Pesos (PHP604,998.00)** only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of a contract for Shipment of Personal Effects of Consul General Celeste Vinzon-Balatbat from Nagoya, Japan to Santiago, Chile, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
