RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF CATERING SERVICES FOR THE DIPLOMATIC/CONSULAR RECEPTION IN CONNECTION WITH THE COMMEMORATION OF THE 126TH ANNIVERSARY OF THE CELEBRATION OF PHILIPPINE INDEPENDENCE ON 15 JUNE 2024 AT EDION HISAYA PLAZA

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement Catering Services for the Diplomatic/Consular Reception in connection with the Commemoration of the 126th Anniversary of the Celebration of Philippine Independence on 15 June 2024 at Edion Hisaya Plaza.

WHEREAS, the procurement of a contract for the procurement of Catering Services for the Diplomatic/Consular Reception in connection with the Commemoration of the 126th Anniversary of the Celebration of Philippine Independence on 15 June 2024 at Edion Hisaya Plaza in the amount of Thirty Thousand Yen (JPY30,000) or approximately Twelve Thousand Pesos (PhP12,000.00)

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 02 May 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **RINGS CATERING AND DELIVERY** (JPY867,900: *FAILED- Quotation Exceeded ABC*), the **WITHWIN ORANGE CATERING CO.** (JPY888,800: *FAILED-- Quotation Exceeded ABC*) and the **CEZARS' KITCHEN** which showed the lowest calculated and most responsive quotation, in the amount **Twenty Six Thousand Three Hundred Thirty-Four Yen (JPY715,000 or approximately PhP268,000.00)** only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Catering Services for the Diplomatic/Consular Reception in connection with the Commemoration of the 126th Anniversary of the Celebration of Philippine Independence on 15 June 2024 at Edion Hisaya Plaza, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
