RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF GENERAL COMPREHENSIVE INSURANCE AND COMPULSORY AUTOMOBILE LIABILITY INSURANCE FOR NAGOYA PCG's OFFICIAL VEHICLES TOYOTA ALPHARD (HV X 2021) AND MERCEDES BENZ (E450 4-MATIC 2021)

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake Procurement of General Comprehensive Insurance and Compulsory Automobile Liability Insurance for Nagoya PCG's Official Vehicles Toyota Alphard (HV X 2021) and Mercedes Benz (E450 4-Matic 2021);

WHEREAS, the procurement of a contract for the Procurement of General Comprehensive Insurance and Compulsory Automobile Liability Insurance for Nagoya PCG's Official Vehicles Toyota Alphard (HV X 2021) and Mercedes Benz (E450 4-Matic 2021) has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2024 in the amount of Six Hundred Thousand Yen (JPY600,000) or approximately Two Hundred Fifty Thousand Two Hundred Fifty-Seven and 14/100 Pesos (PhP250,257.14).

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 01 March 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **TOKYO MARINE NICHIDO** (*FAIL – Did not submit Compulsory Automobile Liability Insurance*), the **NISSIN FIRE AND MARINE INSURANCE, CO.** (*FAIL – Did not submit Compulsory Automobile Liability Insurance*), and the **MITSUI SUMITOMO INSURANCE COMPANY** which showed the lowest calculated and most responsive quotation, in the amount of Five Hundred Ninety-Six Thousand Eight Hundred Twenty Yen (**JPY596,820**) only (approximately PhP238,983.78), inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for Procurement of General Comprehensive Insurance and Compulsory Automobile Liability Insurance for Nagoya PCG's Official Vehicle (Toyota Alphard HV X 2021), subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
