**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF
MONTHLY POTABLE WATER FOR CONSULATE PERSONNEL**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of Monthly Potable Water for Consulate Personnel.

WHEREAS, the procurement of a contract for the procurement of Monthly Potable Water for Consulate Personnel has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2024 in the amount of One Million Five Thousand Yen (JPY1,005,000) or approximately Three Sixty Thousand Yen (JPY60,000) or approximately Twenty-Four Thousand Pesos (PhP24,000.00).

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 23 April 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **RAKUMIZU** (*JPY3,820-monthly or JPY61,600-annually: FAILED-Exceeded ABC*), the **AQUA STYLE** (*JPY4,180-monthly or JPY50,160-annually: FAILED-has five (5) years lock-in period not advantageous to the Procuring Entity*) and the **WATER STAND CO., LTD.** which showed the lowest calculated and most responsive quotation, in the amount (*JPY4,400 monthly or JPY52,800 annually approximately PHP1,760 per month or PHP21,105 per year*) only, inclusive of taxes and other charges

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Monthly Potable Water for Consulate Personnel, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
