## RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF FOOD SERVICES FOR NAGOYA PCG'S THIRD QUARTER FY 2024 PLANNING SESSION

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement Food Services for Nagoya PCG's Third Quarter FY 2024 Planning Session;

WHEREAS, the procurement of a contract for the procurement of Food Services for Nagoya PCG's Third Quarter FY 2024 Planning Session has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2024 in the amount of One Hundred Twenty-Thousand Yen (JPY120,000) or approximately Forty-Five Thousand Pesos (PHP45,000.00) only.

**WHEREAS**, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 12 July 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: THE KAWABUN NAGOYA (JPY8,000 per pax or total of JPY176,000: FAIL- Exceeded ABC), the TIAD, Autograph Collection Hotel (JPY8,500 per pax or total of JPY187,000) and the NAGOYA TOKYU HOTEL which showed the lowest calculated and most responsive quotation, in the amount of JPY4,900 per pax or total of One Hundred Seven Thousand Eight Hundred Yen (JPY107,800) or approximately PhP40,500 only, inclusive of taxes and other charges (Tax Exemption is allowed).

**NOW**, **THEREFORE**, we, the members of the Procurement Committee, RESOLVE to RECOMMEND to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Food Services for Nagoya PCG's Third Quarter FY 2024 Planning Session, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
