**RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT
THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF
VARIOUS FURNITURE OF THE CONSULATE**

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of Two (02) Lots of Various Furniture of the Consulate;

WHEREAS, the procurement of a contract for the procurement of Two (02) Lots of Various Furniture of the Consulate has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2024 in the amount of Four Hundred Thousand Yen (JPY400,000) or approximately PhP156,000.00, only.

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 13 September 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **MONOTARO CO., LTD.** (JPY 141,320: *Incomplete Quotation*), **ASKUL CORP.** (JPY 135,600 *Incomplete Quotation*), **CUCCINA NAGOYA** (JPY 768,020: *Above ABC and Incomplete Quotation*), **IDOTSUKA** and **OFFICE.COM** (JPY 331,729: *Incomplete Quotation*), which showed the lowest calculated and most responsive quotations, in the amounts **JPY 132,000** and **JPY 213,400** with the total amount of **Three Hundred Forty-Five Thousand Four Hundred Yen (JPY345,400)** only or approximately **PHP134,706.00**, inclusive of taxes and other charges;

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Various Furniture of the Consulate, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
