RESOLUTION RECOMMENDING, BY REFERENDUM, AWARD OF CONTRACT THROUGH GPBB RESOLUTION NO. 28-2017 FOR THE PROCUREMENT OF VARIOUS OFFICE AND ICT SUPPLIES, SEMI-EXPENDABLE EQUIPMENT, AND OTHER MATERIALS

WHEREAS, the Consulate General of the Philippines, Nagoya intends to undertake procurement of Various Office and ICT Supplies, Semi-Expendable Equipment, and other Materials;

WHEREAS, the procurement of a contract for the procurement of Various Office and ICT Supplies, Semi-Expendable Equipment, and other Materials has an Approved Budget for the Contract to be sourced from Nagoya PCG's MOOE 2024 in the amount of One Million Five Hundred Thousand Yen (JPY1,500,000) or approximately PhP600,000.00, only.

WHEREAS, pursuant to GPBB Resolution No. 28-2017, a Request for Quotation (RFQ) was posted on the website and premises of the Consulate General of the Philippines, Nagoya reserved for this purpose starting on 19 September 2024;

WHEREAS, the Consulate General of the Philippines, Nagoya sent requests for quotation to three (3) different companies, namely: the **MONOTARO CO., LTD.** (JPY 1,581,023: *FAILED- Exceeded ABC*), the **KAUNET CO., LTD.** (JPY 1,781,617: *FAILED- Exceeded ABC*) and the **ASKUL CORP.** which showed the lowest calculated and most responsive quotation, in the amount of **One Million Three Hundred Fifty-Two Thousand Nine Hundred Seventy-Nine Yen (JPY1,352,979) only, or approximately PHP527,662.00**, inclusive of taxes and other charges;

NOW, THEREFORE, we, the members of the Procurement Committee, **RESOLVE** to **RECOMMEND** to the Head of the Procurement Committee to resort to Resolution 28-2017 for the procurement of Various Office and ICT Supplies, Semi-Expendable Equipment, and other Materials, subject to the above-mentioned requirements and provided that existing auditing rules and regulations shall be strictly observed by the end-user.
